The status of general bibliography as a special scientific methodology determines the range of such theoretical issues, the solution of which constitutes the content of this relatively independent sub-system of bibliographic knowledge:

- to determine and study the essence and the most general logical and historical laws of the book as an objective phenomenon of social existence, as well as the emergence, development and methods of existence (that is, processes and forms) of the book as a method of existence of the book. ;

- researching the historical process of bibliographic knowledge and the laws of its emergence and development;

- substantiating the object, subject, structure, interdisciplinary and intra-disciplinary relations of book studies knowledge;
- development and coherent statement of the theory of the method of bibliographic knowledge:
 - development and systematization of the apparatus of categories and concepts of bibliography;
 - development of book typology as a methodological basis for typology and classification of book publications in special book studies and some disciplines;
 - general principles of scientific knowledge in book studies: objectivity, reflection and development, systematicity, unity of theory and practice, as well as interpretation of historical and logical approach;
 - to study the nature and forms of interactions between book studies and other scientific disciplines;
 - development of the scientific basis of management of the practice of book publishing and the processes of the book's use in society. The listed problems represent the system of the subject of general bibliography more fully. In general, it can be described as a comprehensive and consistent statement of the general theory of the book and the general theory of scientific knowledge about it.

The object of general bibliography is the theoretical model of the multi-level system "book in book work". Prof. A. A. Belovitskaya, while analyzing the field of objects of the science of book and library work, writes: "... the object of specialized book studies includes the corresponding type of practical activity in the field of book studies - book publishing, book sales, librarianship, the model of bibliography activity is introduced, because in the field of book forms and some of its scientific objects, at the level of existence method forms, a real book in the form of a book publication and its existence forms apply. The activity of practical bibliography is aimed at its creation, bibliography, distribution, distribution and redistribution with the tools of book trade and librarianship. The typological method is a dialectical unity of the general forms of its existence, such as the historical-typological method of bibliography and the logical-typological method. Their similarities and differences reflect the dialectic of history and logic in scientific knowledge. Its essence is expressed in the principle of the unity of historicity and logic: "The historical approach is not only a reflection of the phenomenon under study, but also the laws that determine the transition from

one stage of the formation and development of the object to another. It also implies the identification of important connections between; therefore, historicity in the dialectical method does not exclude rationality, but is in harmony with it. Here, historicity is free from coincidences, corrected according to the law of the historical process. It is a form of logical movement that reflects the important connections and relationships that are manifested in the process of formation and development of the object being studied. Historical-typological and logical typological subsystems of the typological method, in turn, can appear in the form of their types depending on the consistency of the typological process: "component-typological method, functional-typological method. Each of them applies in its historical aspect, with the historical formation and development of the structure, structure and functions of the phenomenon of bibliography studied and explained, the essence, method and forms of existence of the phenomenon of bibliography, its composition if the theory of its structure and functions is developed and explained, it is valid in its logical aspect.
