It is also possible for a person to organize his psychic activity in a purposeful way and direct it to a certain content. The Will puts a person's behavior in the direction on the one hand, and on the other hand organizes a person's psychic activity based on existing tasks and requirements. It affects the content of personality activity. The volitional character of a person does not consist in simply fulfilling his goals, various fists. perhaps the willful character has its own. This means that a person subjugates other motives of behavior that are not so significant for him to those goals that stand before him and are of great importance to him.

Volitional actions are done consciously, different from involuntary work-actions. In this case, the activity of the mind is manifested in the determination of the purpose of action, in the preliminary determination of the means and directions for achieving this goal, in the development of a certain decision and in the execution of this decision. Yu.A.Gorbunov points out that when nimaki is voluntary, then he is conscious –conscious. There must be some kind of independent force between thoughts and desires on the one hand and actions on the other, and this is called willpower. A person is willing to act in accordance with or inversely with his thoughts and desires. He defined the function of the will as: "the Will can bring, end, strengthen and weaken action" it follows that when a person perceives his behavior in conscious clarity, the Will does not become associated only with mobilization and overcoming obstacles.

Will dictates the conscious control of one's own behavior, the restraint of a number of aspirations and desires. The volitional character is such that from this a person becomes self-governing, self-reliant, keeps control over his own prejudices and controls them for the rest of the time he needs them. The manifestation of Will is the activity of a person, which is a connection with the participation of consciousness in work-activities.

Methods for determining and evaluating volitional qualities are characterized by their own variety of colors. A strong will is not only to want something or achieve it, but also to force oneself to give up that desire when it is necessary.

V.K. Kalin argues that sometimes, keeping one of the human movements in check leads to the activation of the other. Researchers have been able to record phenomena in their activities, such as the characteristics of movements in normal and difficult conditions, their productivity.

The collected data analysis shows that the Will is embodied in motives, goals, selfassessment, actions, activities6. Therefore, willpower is the conscious control by a person of habits and actions that require overcoming external and internal difficulties.

Looking at the history of psychology, we see that with volitional qualities, the study of the relationship of personality temperament is also focused. V.K.Kalin puts forward the reasoning that the characteristics of the nervous system and temperament can affect the frequency of situations that require the emergence of a similar control, and not the effectiveness of volitional management.
